Form Motion

Authorize the CEO/General Manager to award Purchase Order MNT24-53, Relief Vehicles to Freeway Toyota of Handford, California for the provision of sixteen (16) vehicles in the amount of \$516,024.64, with a ten (10) percent contingency of \$51,602.46 for a total not to exceed amount of \$567,627.10.

Background

This item was reviewed by the Administrative & Finance Committee at its October 10, 2024 meeting and recommended to the Board of Directors for approval.

Omnitrans proposes to purchase sixteen (16) Toyota Camry Hybrid cars under the State of California, Department of General Services (DGS) Contract #1-22-23-10C, Line Item #21.

Omnitrans requires the use of relief vehicles for coach operators to start and end shifts in various locations throughout our service area. This allows for timely exchanges of personnel without disruption to service.

The proposed purchase of these vehicles utilizes the State of California, Department of General Services (DGS) Contract #1-22-23-10C. This statewide DGS contract leverages broader economies of scale than an individual, agency-specific small solicitation. The firms on the DGS contract were selected through a larger, FTA-compliant solicitation.

By proceeding with this award, Omnitrans will replace vehicles that were purchased in 2016 and have reached the end of their useful life.
